THE FACTORING REGULATION (AMENDMENT) BILL, 2020

THE MINISTER OF FINANCE AND MINISTER OF CORPORATE AFFAIRS (SHRIMATI NIRMALA SITHARAMAN) *moving the motion for consideration of the Bill said:* The Factoring Regulation Act of 2011 was enacted in 2011 because MSMEs were struggling to have their payments done in time. Now, we are trying to come up with some amendments to that Bill. These amendments are the direct result of the recommendations of the U.K. Sinha Committee. Initially, the Bill was sent to the Standing Committee and all the recommendations of the Standing Committee have been accepted by the Government. Accordingly, there are three Amendments to the existing Act and one is the insertion of Section 19 (1) (A). Therefore, this is a very important Bill, which will benefit the MSMEs and since, the MSMEs will be benefited, I appeal to the whole House to consider and pass this Bill.

The Bill, as amended, was passed.

**THE NATIONAL INSTITUTES OF FOOD TECHNOLOGY,
ENTREPRENEURSHIP AND MANAGEMENT BILL, 2021**
(As passed by Rajya Sabha)

THE MINISTER OF FOOD PROCESSING INDUSTRIES (SHRI PASHUPATI KUMAR PARAS) *moving the motion for consideration of the bill*

said: that the Bill to declare certain institutions of Food Technology, Entrepreneurship and Management to be the institutions of national importance and to provide for instructions and research in food technology, entrepreneurship and management and for the advancement of learning and dissemination of knowledge in such branches and for matters connected therewith or incidental thereto, as passed by Rajya Sabha, be taken into consideration.

The Bill was passed.
