Regarding implementing e-Constituency Management and organising training-cum-workshop in Sub-divisions of Himachal Pradesh.

Sir,

I am directed to kindly inform you that Sh. - 1) MLA Diary (e-Correspondence with departments)
- 2) Public Works (Sanctioned & Location details, Monthly Financial & Physical progress with images)
- 3) Grievances/Suggestions from Public Representatives to the Hon'ble MLA (My MLA mobile app)






