#### DETENTION AND RELEASE OF SHRI ANIL FIROJIYA

The following communication dated 20 September, 2019 from Superintendent of Police, District Ujjain was received on 23 September, 2019:-

"This is to inform that Shri Anil Firojiya, Member of Lok Sabha was detained u/s 151 of Cr.PC at 1415 hrs. on 20 September, 2019 while entering the office of Collector forcibly and attempting to commit a crime. He was taken into custody and kept in confinement in open jail, Dussehra Maidan, Ujjain. He was later released on bail at 1500 hrs. on the same day."
