#### RESOLUTIONS

**17. FURTHER DISCUSSION** on the following resolution moved by Shri Ritesh Pandey on the 20th March, 2020 :-

"Keeping in view that the Anganwadi Workers and Welfare Anganwadi Helpers provide many essential *measures for* health and welfare services to women, children Anganwadi and adolescents, this House urges upon the Workers and Government to take following immediate steps to *Anganwadi* uplift their working conditions –

Helpers.

- (1) regularisation of employment of Anganwadi Workers and Anganwadi Helpers;
- changing the nomenclature (2) of compensation category of Anganwadi Workers and Anganwadi Helpers from "Honorarium" to "Salary";
- (3) payment of adequate amount of compensation to Anganwadi Workers Anganwadi Helpers, which would reflect importance of their services to the society;
- improving working conditions Anganwadi Workers and Anganwadi Helpers and upgrading every Anganwadi Centre with all basic facilities including availability of safe drinking water, clean toilets and proper ventilation; and
- (5) payment of all dues including pending rent for Anganwadi Centres which are being run on rented accommodation in the country.".

#### 18. SHRI RAVI KISHAN to move :-

"This House urges upon the Government to bring forward a suitable legislation to include 'Bhojpuri' language in the Eighth Schedule to the Constitution.".

#### **19. DR. SHRIKANT EKNATH SHINDE** to move :-

"Having regard to the facts that-

- (i) to achieve rapid growth both inclusive and <u>redevelop</u> sustainable, there is a need to tackle the <u>cities to</u> challenges for urban planning in India; <u>achieve ra</u>
- (ii) need is to rebuilt new cities and generate <u>growth both</u> additional spaces within existing cities and their <u>inclusive and</u> peripheries so as to facilitate and accommodate <u>sustainable to</u> rapid urbanization; <u>tackle the</u>
- (iii) the current urban planning regime in <u>challenges for</u> India is rooted in the Town and Country Planning <u>urban planning</u> Act,1947 and is primarily focused on detailed <u>in the country.</u> land use zoning;
- (iv) policymakers need to address the issues like inclusiveness, governance, ecology and at the same time maintaining the unique identity of respective cities;
- (v) transfer of the urban planning function from States or Union territories to elected urban local governments did not happen as was envisaged through the Constitution (Seventy-Fourth Amendment) Act 1992; and
- (vi) ever-changing demographics, new technologies and global and local socio-political shifts demand urban planning demands flexibility to ensure future-readiness;

Need to redevelop cities to achieve rapid growth both inclusive and sustainable to tackle the challenges for urban planning in the country.

this House urges upon the Government to -

- (a) chalk out a model 'master plan', to be instrumental for guiding and regulating the development of cities for managing urbanisation as well as 'spatial sustainability';
- (b) implement the proposed central sector scheme "500 Healthy Cities Programme" for a period of five years to integrate the planning of cities with public health and ensure a healthy city for all by the year 2030;
- (c) empower the Urban Local Bodies for carrying out urban planning and development;
- (d) compulsorily teach urban planning in school for awareness on planning and need for trained urban planners;
- (e) ensure timely implementation of Urban Development schemes like Smart Cities, Atal Mission for Rejuvenation And Urban Transformation (AMRUT) and Pradhan Mantri Awas Yojana – Urban (PMAY-U);
- (f) promote use of multi modal and eco friendly transport such as electric buses and E-vehicles;
- (g) address the water supply issues and improve the water and wastewater management in the country which includes cleaning up of polluted rivers;
- (h) implement measures such as biomining, waste segregation and converting waste to energy projects at a community level; and
- (i) redevelop cities with an awareness of the specific needs of all citizens including older adults, specially abled and women.".

#### 20. SHRI P.P. CHAUDHARY to move :-

- " Having regard to following:-
  - (i) the government has allocated rupees 44,605 crores and taken a historic step by launching the river interlinking project to help the water starved region's and boost socio economic prosperity;
  - (ii) the Ken- Betwa interlinking project is expected to provide annual irrigation to 10.62 hectares of land, drinking water to a population of 62 lakhs and generation of 103MW hydropower in the State of Uttar Pradesh and Madhya Pradesh;
  - (iii) in order to ensure minimum human footprint and to arrest animal migration and habitat loss targeted initiatives are required;
  - (iv) although the Detailed Project Reports have been finalised for the five Interlink projects, the government needs to ensure speedy consensus between the benefitting States;
  - (v) there are several remote regions in the country where the interlinking projects may ensure availability of a water source for the first time since independence;
  - (vi) the development and growth of the robust inter linking project may provide a backbone for the agriculture activities in the country, irrigation facilities in water deficient places and reduce flooding and destruction in the water surplus areas,

this House urges upon the Government to frame a comprehensive policy providing for: -

(a) establishment of an independent autonomous body for planning, investigating, financing and implementing the river interlinking projects in the country;

Formulation of a comprehensive policy for development of river interlinking projects in the country.

- (b) timely identification of areas that are water starved and may benefit from river linking projects and prioritization of projects based on the needs of the region, number of beneficiaries and availability of alternate sources of water, etc;
- (c) development of partnership model and framework that regulates water sharing between the Centre and the beneficiary States for the development of same;
- (d) developing policies to minimise human and animal migration and to avoid damage to animal habitat and the surrounding ecosystem;
- (e) consideration of steps to be taken up while implementing the river interlinking project and its impact on flora and fauna resulting from such displacements; and
- (f) re-establishment and rehabilitation of the people displaced due to the river interlinking projects.".

#### 21. SHRI GOPAL CHINAYYA SHETTY to move :-

" Having regard to the fact that:-

- (i) there has been a significant increase in the pendency of cases at each level of the judicial hierarchy and more than 3.5 crore cases are lying pending in the Supreme Court, High Courts and Subordinate Courts;
- (ii) out of the total pending cases, more than 87.3 per cent. are lying pending in the subordinate courts, 12.5 per cent. in High Courts and the remaining 0.2 per cent. cases are lying pending in the Supreme Court; and
- (iii) more than 8.3 lakh cases are lying pending in the High Courts for ten years and more than 24 lakh cases are lying pending in the Subordinate Courts for ten years,

this House urges upon the Government to take immediate steps for construction of new buildings for
