He was later released by the Court of Additional District Magistrate on bail bond on the same day."

ARREST AND RELEASE OF SHRI VELLALATH KOCHUKRISHNAN NAIR SREEKANDAN

The following communication dated 06 September, 2019 from Chief Judicial Magistrate, Palakkad, Kerala was received on 20 September, 2019:-

"I have the honour to inform you that Shri V.K. Sreekandan, Member of the Lok Sabha, Palakkad Constituency, Kerala was tried at the Chief Judicial Magistrate's Court, Palakkad, Kerala before me on charges u/s. 143, 147, 148, 283 r/w 149 IPC and Sec. 3, 4 r/w 6 of Kerala Public ways (Restriction of Assemblies and Procession) Act, 2011.

On 6.9.2019, after a trial lasting for 2 years 1 month and 20 days on pleading guilty of charge, I found Shri V.K. Sreekandan guilty u/s. 143, 147, 148, 283 r/w 149 IPC and Sec. 3, 4 r/w 6 of Kerala Public ways (Restriction of Assemblies and Procession) Act, 2011 and sentenced him to simple imprisonment till rising of the Court and for payment of total fine of Rs. 650/- (Six Hundred and Fifty Only). He had undergone the sentence and remitted the fine. He is released on the same day."
