## RESOLUTIONS

**19. FURTHER DISCUSSION** on the following resolution moved by

Shri Ritesh Pandey on the 20th March, 2020 :-

"Keeping in view that the Anganwadi Workers and Welfare Anganwadi Helpers provide many essential measures for health and welfare services to women, children Anganwadi and adolescents, this House urges upon the *Workers and* Government to take following immediate steps to Anganwadi uplift their working conditions -

Helpers.

(1) regularisation of employment of Anganwadi Workers and Anganwadi Helpers;

(2) changing the nomenclature of compensation category of Anganwadi Workers and Anganwadi Helpers from "Honorarium" to "Salary";

(3) payment of adequate amount of compensation to Anganwadi Workers and Helpers, Anganwadi which would reflect importance of their services to the society;

working (4) improving conditions of Anganwadi Workers and Anganwadi Helpers and upgrading every Anganwadi Centre with all basic facilities including availability of safe drinking water, clean toilets and proper ventilation; and

(5) payment of all dues including pending rent for Anganwadi Centres which are being run on rented accommodation in the country.".

### 20. SHRI RAVI KISHAN to move :-

"This House urges upon the Government to bring forward a suitable legislation to include 'Bhojpuri' language in the Eighth Schedule to the Constitution.".

Inclusion of 'Bhojpuri' language in the Eiahth Schedule.

## 21. DR. SUJAY RADHAKRISHNA VIKHEPATIL to move :-

"Having regards to the facts that –

(i) the second wave of COVID-19 pandemic steps to has resulted in identifying the gaps in the existing healthcare infrastructure of the country and the *healthcare* third wave has shown a subsequent need for *facilities in the* preparedness;

(ii) India's public expenditure on healthcare is 1.2 per cent. of the Gross Domestic Product (GDP) in the Financial Year (2021-2022), whereas average expenditure of the Organisation for Economic Co-operation and Development (OECD) countries is estimated to be 8.8 per cent. of their GDP on healthcare;

(iii) healthcare sector has been unable to sequence majority of COVID-19 samples in reasonable period of time due to lack of sufficient number of genome sequencing centres in the country;

(iv) administration of public healthcare system needs to be overhauled;

(v) the pandemic has resulted in collection of bio-medical waste and needs an efficient system to collect, manage and dispose of the waste being accumulated without causing danger to the public health; and

improve country. (vi) the beneficiary database of the Ayushman Bharat-Pradhan Mantri Jan Arogya Yojna needs to be updated by adding new beneficiary, if any, this House urges upon the Government to -

(1) review the National Health Policy, 2017;

(2) increase expenditure on healthcare sector of the country from 1.2 per cent. to at least 5 per cent. of GDP by the year 2025;

(3) ensure establishment of a cooperative federalism model in healthcare sector by way of amending the Seventh Schedule to the Constitution by transferring the subject matter of public health from State List to Concurrent List so that both the State and Central Government may take appropriate measures to assist the healthcare sector;

(4) ensure creation of 'Indian Health Services' on similar pattern with Indian Administrative Services by amending the All-India Services Act, 1951;

(5) issue guidelines to the States regarding timely payment of wages to all the healthcare workers;

(6) ensure installation of 200 Common Biomedical Waste Treatment Facilities all across the nation for their optimum utilisation;

(7) ensure establishment of genome sequencing lab in each district for effectively identifying new variants of COVID-19; and

(8) utilize the dataset under National Food Security Act, 2013 for rationalization and inclusion of disadvantaged people of the country under *Ayushman Bharat- Pradhan Mantri Jan Arogya Yojana.*"

## 22. SHRI VE. VAITHILINGAM to move :-

"Keeping in view the welfare of the student community of the Union territory of Puducherry, this House urges upon the Government to take necessary steps to provide for twenty-five per cent. reservation of seats in all courses conducted by the Pondicherry University established by an Act of Parliament in the year 1985 to the students of Union territory of Puducherry.".
