Separate ballots will be held for notices of Starred and Unstarred Questions on dates specified above.

Members are further informed that notices of Questions for the sittings to be held on 18.07.2022 and 19.07.2022 received upto 1300 hours on 01.07.2022 (Friday) will be balloted on 01.07.2022 (Friday) after 1500 hours.

The Ballots will be held in the Lobby of the Central Hall, between the First-Aid-Post and Lounge No. 5-B, Parliament House or in Question Branch, Room No. 324, Parliament House Annexe after 1300 hours.

Members are requested to make it convenient to witness the balloting of the Notices of Starred and Unstarred Questions at the said timings and the dates.
