BUDGET SESSION WEDNESDAY, MARCH 12TH, 2025

The House met at 10 a.m. with Hon'ble Speaker in the Chair and sat till 03:01 P.m.

The day was allotted for Government Business.

1. **<u>OUESTIONS</u>**:

Question No. 86 - 89 were taken up and disposed off.

2. LAYING OF STATEMENT:

Shri SHAKLIAR WARJRI, Minister in – charge Labour, Employment & Skill Development laid an Assurance Statement pertaining to **Starred Question No. 52** asked by **SHRI NUJORKI SUNGOH, MLA on** 7th **March, 2025**.

ANNOUNCEMENT:

The Hon'ble Speaker informed that he has received a letter from the Chief Minister that he will not be able to attend the Ninth day of the Budget Session. All necessary reply will be made by Shri Prestone Tynsong, Deputy Chief Minister on his behalf.

After discussion and reply by the Minister in- charge, the Cut Motion was withdrawn with the leave of the House. The Grant was then put to vote and passed by the House.

Grant No. 9, 10, were moved by the Ministers in-charge and passed by the House.

Grant No. 11 - Cut Motion was moved by Shri Ardent M. Basaiawmoit, MLA. He initiated discussion, Shri Brightstarwell Marbaniang, Shri Charles Pyngrope, Dr. Mukul Sangma, Leader of Opposition, Shri Adelbert Nongrum, Shri Nujorki Sungoh, Govt. Deputy Chief Whip, Shri Balajied Kupar Synrem, Shri Rupa R. Marak, and Shri Renikton Lyngdoh Tongkhar also participated. After discussion and reply by the Minister in- charge, the Cut Motion was not withdrawn by the mover Shri Ardent Miller Basaiawmoit, MLA.

The Grant was then voted and passed by the House.
