(a) Sir, on receipt of failure report of the transformer from the field officer, the transformer availability in the stock is checked and accordingly the transformer is allotted and issued to the field for replacement.

- (b) The estimated duration for the replacement of the damaged transformer?
- (b) Sir, the time required to restore power after the replacement of a failed Distribution Transformer (DT) can vary based on several factors:

Severity of the Failure: If there is significant damage to surrounding infrastructure (e.g., cables, poles), additional time may be needed for repairs before the new DT can be installed.

Availability of Replacement DT: If a suitable replacement transformer is readily available in the store, the process can begin almost immediately. However, if the DTs need to be sourced from another location, transportation time can add to the overall restoration time.

Accessibility of the Site: The location of the failed DT can impact restoration time. Remote or difficult-to-access areas may require more time for equipment and personnel to reach the site.

<u>Weather Conditions</u>: Adverse weather conditions, such as heavy rain, storms etc., can delay the replacement process and extend the restoration time.

However, the MePDCL tries its best to replace the damaged transformer in the shortest possible time which is within 1 day in urban areas and 4 days in rural areas.
