BUDGET SESSION THURSDAY, MARCH 13TH, 2025

The House met at 10 a.m. with Hon'ble Speaker in the Chair and sat till 04:03 P.m. The day was allotted for Government Business.

1. Questions.

Question Nos. 98 to 102 were taken up and disposed off.

2. ANNOUNCEMENT:

Shri CONRAD K. SANGMA, Chief Minister made a Suo Moto statement Under Rule 55 of the Rules of Procedure and Conduct of Business.

3. ZERO HOUR NOTICE:

The Hon'ble Speaker informed the House that he has received A Zero Hour Notice by Shri Adelbert Nongrum, MLA on the news item published in "Nongsain Hima", dated 12th March, 2025, under the caption "Rah ki pulit ia U bah ban tohkit halor ka jingkhlad ka longkmie bad ka khun ha Langtor."

The Hon'ble Speaker informed that it was decided in the BAC that on a day allotted for Demand for Grants no other business shall be taken up and also adopted by the House on 28th February, 2025. So, the Zero Hour cannot be admitted today. However, I would like to inform the Hon'ble Member that the Notice will be provided by the Assembly Secretariat to the Chief Minister's Office. The Hon'ble Member may take up the matter with the Hon'ble Chief Minister who will look into it.

Basaiawmoit, Shri Heaving Stone Kharpran, Shri Rupa N. Marak, Shri Renikton L. Tongkhar, Dr. Mizanur Rahman Kazi also participated. After discussion and reply by the Minister in- charge.

6. Shri CONRAD K. SANGMA, Chief Minister in-charge Finance beg leave to introduce the Meghalaya Appropriation (No. II) Bill, 2025.

Shri PRESTONE TYNSONG, Deputy Chief Minister in-charge Parliamentary Affairs moved "that the second proviso to Sub Rule (c) of Rule 72 of the Rules of Procedure and Conduct of Business in its application to the Meghalaya Appropriation (No II) Bill, 2025 be suspended for the time being in so far the Rule requires circulation of the Bill four days in advance before the Motion for consideration may be moved."

7. Shri Conrad K. Sangma, Chief Minister in-charge Finance to move that The Meghalaya Appropriation (No. II) Bill, 2025 be taken into consideration.

The Bill was taken into consideration and passed by the House.

8. Shri Conrad K. Sangma, Chief Minister in-charge Finance, moved that the Meghalaya Ceiling on Government Guarantee Bill, 2025 be taken into consideration.
