TERMINATION OF WORK IN NATIONAL HIGHWAY

Deputy Chief Minister, Planning and Transformation, National Highways. Will the Minister of National Highway be pleased to state the following : 1. Whether the work on the Kohima- Jessami road on NH- 29 Pg V (old NH150) (KJ-V) (Km 95.700 to design km 117.200) was terminated on 15.03.2023 due to slow progress? (a) If so, when a work progress on 1.49% per month can be terminated in an instance why is KJ-II still not terminated? 2. Is it true that

Article 23 of the Termination Clause of NHIDCL states that :- "Without prejudice to any other rights or remedies which the authority may have under this agreement, upon occurrence of a Contractor Default, the Authority shall be entitled to terminate this Agreement by issuing a Termination Notice to the Contractor, provided that before issuing the Termination Notice, the Authority shall by a notice inform the Contractor of its intention to issue such Termination Notice and grant 15 (fifteen) days to the Contractor to make a representation and may after the expiry of such 15(fifteen) days, whether or not it is in receipt of such representation, issue the Termination Notice." This Termination Clause clearly shows that the above mentioned case is fit for Termination. So, why has it not been terminated yet? (a)What is the reason for the delay in termination. Furnish the termination notice if it has been issued. (b)State the reasons why KJ-V can be terminated?
