I have received letters dated 18<sup>th</sup> of October, 2025 from the following herein above-mentioned Hon'ble Members of the Nationalist Democratic Progressive Party (NDPP); wherein the Hon'ble Members, as mentioned, of this 14<sup>th</sup> House has unanimously decided to merge with Naga Peoples Front (NPF) on 18<sup>th</sup> October, 2025. The Hon'ble Members have presented themselves before me in the presence of Party President, Naga Peoples Front (NPF) Shri. Apong Pongener and General Secretary Shri. Achumbemo Kikon conveying the acceptance of the merger of both the political Party and the Legislature Party of the NDPP with the NPF. Furthermore, a letter dated 18.10.25 has been received from Dr. Neiphu Rio, Hon'ble Chief Minister and Leader of Legislature Party of the NPF confirming the aforesaid developments. Two Hon'ble Members Shri. K. Tokugha Sukhalu and Shri. Moatoshi Longkumer have also given their consent for the Merger via Video Conference on this the 18<sup>th</sup> October, 2025.

I hereby, in accordance with the provisions of the Members of the Nagaland Legislative Assembly (Disqualification on ground of defection) Rules 2019 direct the Additional Secretary of the Nagaland Legislative Assembly to publish revise summary as per rule 4 (3).

I have perused paragraph 4(2) of the Tenth Schedule of the Constitution of India. I have also seen the relevant provisions of The Members of Nagaland Legislative Assembly (Disqualification on Ground of Defection) Rules, 2019.

### O R D E R

I, therefore, in accordance with the provision of Paragraph 4(2) of the Tenth Schedule of the Constitution of India and in consonance with The Members of Nagaland Legislative Assembly (Disqualification on Ground of Defection) Rules, 2019, I hereby declare the merger of all the 31 (Thirty One) Hon'ble Members of the Nationalist Democratic Progressive Party (NDPP) as mentioned above with the Naga Peoples Front (NPF) with effect from 18.10.2025. The Order may be circulated as per the procedure.


