**UNDER PARA 4(2) OF THE TENTH SCHEDULE readwith "THE MEMBERS OF  
THE NAGALAND LEGISLATIVE ASSEMBLY (DISQUALIFICATION ON  
GROUND OF DEFECTION) RULES, 2019"**

I have received letters dated 31<sup>st</sup> May, 2025 from the following herein above-mentioned Hon'ble Members of the Nationalist Congress Party (NCP); wherein the Hon'ble Members, as mentioned, of this 14<sup>th</sup> House has unanimously decided to merge with Nationalist Democratic Progressive Party (NDPP) on 31<sup>st</sup> May, 2025. The Hon'ble Members have presented themselves before me on the same day i.e, on the 31<sup>st</sup> May, 2025. Moreover, I have also received a letter from Shri. Chingwang Konyak President, Nationalist Democratic Progressive Party (NDPP) confirming this fact.

I hereby, in accordance with the provisions of the Members of the Nagaland Legislative Assembly (Disqualification on ground of defection) Rules 2019 direct the Secretary-In-Charge of the Nagaland Legislative Assembly to publish revise summary as per rule 4 (3). The proceeding under paragraph 6 of the 10<sup>th</sup> Schedule of the Constitution will be considered upon reference.

I have perused paragraph 4(2) of the Tenth Schedule of the Constitution of India. I have also seen the relevant provisions of The Members of Nagaland Legislative Assembly (Disqualification on Ground of Defection) Rules, 2019.

The Constitutional requirement for merger as per Paragraph 4(2) of the Constitution is 2/3 majority of the Legislature Party of the original Political Party and since all the 7(Seven) Members of the Legislature Party of the Nationalist Congress Party (NCP) constitutes hundred percent, and since the Nationalist Democratic Progressive Party has accepted and requested the Speaker to kindly issue necessary orders, I am satisfied that the claim of merger is a fit case for acceptance.

### **ORDER**

I, therefore, in accordance with the provision of Paragraph 4(2) of the Tenth Schedule of the Constitution of India and in consonance with The Members of Nagaland Legislative Assembly (Disqualification on Ground of Defection) Rules, 2019, I hereby declare the merger of all the 7. (Seven) Hon'ble Members as mentioned above with the Nationalist Democratic Progressive Party (NDPP) with effect from 31.05.2025.

The Order may be circulated as per the procedure.
