RESOLUTION

“That in our State the stray cattle, bulls, calves and buffaloes are severely damaging agriculture and causing numerous accidents and causing distress to farmers common persons.

That the poor farmers of our State have the tendency of abandoning their non-milching and sterile old cows on to the adjoining open roads and fields of their neighborhoods across the whole State.

That some private goshala operations are charging exorbitant money from livestock owners/ farmers to keep such animals with them.

That some obscurantist organizations are not bothered about cow protection, huge agricultural loss to farmers and distress to population afflicted by accidents and only aim to use cow as a conduit and symbol for their nefarious communal game plan.

That so far the concerned authorities of the State Government have remained unresponsive and confused on the issue of the stray cattle menace and also confused on the issue of damage to life due to accidents and loss of livelihoods of farmers, and

Hence, this House resolves that:-

- (A) The Government should guarantee the purchase of all stray cattle at Govt. expenses on predetermined prices for calves, bulls and cows etc.
- (B) Provide 10 lakh compensation to the injured in accidents caused by stray cattle and minimum of Rs.50 lakh to the families of the deceased.
- (C) Compensate farmers for the damage to standing crops caused by stray cattle's, bulls and cows.

- (D) The local administration should efficiency manage the stray cattle problems to provide relief to the distressed population and farmers.
- (E) Prevent those private goshala operators from charging exorbitant amount of money from livestock owners and farmers and take stringent action for mismanagement in such cow shelters.
- (F) Livestock farmers should be given subsidies to compensate the losses incurred in keeping unproductive animals similar to those given to private goshalas.
- (G) Farmers of the State should be made aware at regular intervals, not to allow their animals to stray and incorrigible owners shall be fined for this dereliction.
- (H) Government should amend the existing 'cow protection laws' of the State accordingly."
