#### 2. Ruling by the Hon'ble Speaker

The Hon'ble Speaker, in response to question No.1539, has given a following ruling regarding the transfer of Panchayat land to the Forest Department:

"I feel that the Hon'ble Forest Minister needs to be a bit more proactive in this matter. There are six to seven such projects that are stalled only due to clearance being awaited by Forest Department. This House has significant powers. If any law is causing an obstruction, then it should be amended, but we must expedite this process."

#### 3. Welcome announcement by the Hon'ble Speaker

The Hon'ble Speaker informed the House about the presence of renowned Punjabi writer and Padma Shri Awardee Shri Ninder Ghugianvi in the House. The entire House welcomed him with warm greetings. ## 4. Observation by the Hon'ble Speaker

Regarding the issues raised about Shaheed-e-Aazam Sardar Bhagat Singh and eminent environmentalist Sant Balbir Singh Ji Seechewal, Member, Rajya Sabha, the Hon'ble Speaker made the following observations: -

- 1. "As far as the honor of Shaheed Bhagat Singh is concerned, his honor is above all honors. His honor exists and will always remain."
- 2. "As far as the honor of our martyrs is concerned, there's nothing above it. Our martyrs are honorable to us, they are our guides and our source of inspiration. However, the proceedings of the Legislative Assembly are conducted according to certain rules and regulations."

3. "As far as Sant Seechewal ji is concerned, the way Seechewal ji has worked on environment, worked on purifying water and worked on raising awareness among people, this work has been honored at international level by people including great personalities like President Dr.A. P. J. Abdul Kalam who had been a great scientist. So, I think Mr. Bajwa should himself come here and give his clarification regarding Sant Seechewal."

"I urge all the members that as far as Sant Seechewal ji is concerned, I and the entire Punjab acknowledges his service. Therefore, decorum of words be maintained in the House while referring to him. The service rendered by him has produced results. He has cleared the Kaali Bein. It was lifeless but life has started to sprung up there again. People come from far and wide to Sultanpur Lodhi and visit the Kaali Bein. So, I would say that those who have been honored by the The Times Magazine, honored by great scientists should also be honored by us. There should be no politics."

4. "I completely endorse this fact that no one should speak against the dignity of a saintly personage just because of their name. We should maintain the dignity of saintly persons."
