#### 11.00 a.m.

The Second Session of the Eleventh Assembly commenced on 5<sup>th</sup> February, 2025 at 11.00 a.m. in the Assembly Hall, Gangtok.

The House was presided over by the Hon'ble Speaker, Shri Mingma Norbu Sherpa. All the Hon'ble Members except Hon'ble Minister, Shri Sonam Lama and Hon'ble Member, Shri Samdup Tshering Bhutia were present.

## **INFORMATION BY THE CHAIR**

#### 11.01 a.m. to 11.03 a.m.

The Hon'ble Governor of Sikkim, Shri Om Prakash Mathur, arrived at the Sikkim Legislative Assembly at 11:00 a.m. to address the House. He was warmly welcomed and escorted to the Assembly Hall in a formal ceremonial procession. Upon his arrival at the dais, the National Anthem was played.
