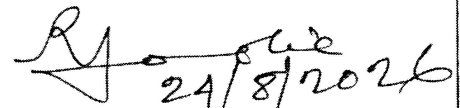


**THE REPORT OF THE BUSINESS ADVISORY COMMITTEE
