(Brief record of the Assembly proceedings of the House)

FRIDAY, THE 28TH MARCH, 2025

PRESENT

The House met in the Assembly House, Agartala at 11.00 AM on Friday, the 28th March, 2025 with the Hon'ble Speaker in the Chair, the Hon'ble Chief Minister, the Hon'ble Deputy Speaker, 10 (Ten) Hon'ble Ministers and 35 (Thirty Five) Hon'ble Members being present in the House.

I. QUESTIONS

- i) Written replies to the Admitted Un-starred Question Nos. 279, 286, 288, 289 and 290 were laid on the Table of the House by the Hon'ble Minister-in-charge of the concerned Department.

II. REFERENCE PERIOD

Statement on the Reference Notice

The Clause 1 to 3 were adopted.

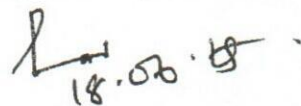
The Schedule of the Bill was adopted.
